1. Brunei Darussalam Central Bank (BDCB) would like to inform members of the public that the BDCB Alert List has been updated.
2. The BDCB Alert List is a list of persons (i.e. companies and individuals) that are currently not licensed, authorised or regulated by BDCB. The Alert List is issued for the public to exercise caution and to avoid being misled to believe that the persons listed are licensed, authorised or regulated by BDCB. This list is without prejudice to any further assessment by BDCB regarding the activities of the persons concerned.

Among the financial products and services that must be licensed by BDCB include money remittance, money changing, money lending and pawn broking services. Members of the public are reminded that they **will not have the protection under BDCB's regulatory framework if they deal with companies or individuals which are unlicensed or unregulated.**
