## CONSTITUTION OF BRUNEI DARUSSALAM (Order under Article 83(3))

## PAWNBROKERS (AMENDMENT) ORDER, 2005

In exercise of the power conferred by Clause (3) of Article 83 of the Constitution of Brunei Darussalam, His Majesty the Sultan and Yang Di-Pertuan hereby makes the following Order -

#### Citation and commencement.

1. This Order may be cited as the Pawnbrokers (Amendment) Order, 2005 and shall commence on the same date as the Pawnbrokers Orders, 2002 (S 60/02).

#### Amendment of section 8 of S 60/02.

2. Section 8 of the Pawnbrokers Order, 2002 (S 60/02), in this Order referred to as the principal Order, is amended in subsection (3) by deleting "\$1,000" and by substituting "5,000" therefor.

#### Amendment of section 18.

- 3. Section 18 of the principal Order is amended in subsection (1) -
  - (a) by deleting ", in addition to the amount of the loan," in the first line; and
  - (b) by inserting "or such other amount as may be agreed between them" immediately after "Schedule" in the second line.

#### Insertion of new sections 19A, 19B and 19C.

4. The principal Order is amended by inserting the following 3 new sections immediately after section 19-

### "Security by pawnbroker.

- 19A. (1) Every pawnbroker shall provide security to the satisfaction of and in a manner determined by the Minister amounting to \$100,000.
- (2) Such security shall remain in force and shall continue for 6 months following the expiration or revocation of the licence.
- (3) The security provided under subsection (1) shall be available to cover all damages and loss of whatsoever nature to or of any article provided to the pawnbroker.

#### Financial statement and accounts.

19B. Every pawnbroker shall submit to the licensing officer a financial statement together with accounts audited by a qualified auditor at the close of each financial year of the pawnbroker.

#### Insurance.

19C. Every pawnbroker shall insure to the satisfaction of the licensing officer every article pawned to him, in respect of all damage and loss of whatsoever nature."

## Repeal of First Schedule.

5. The First Schedule to the principal Order is repealed and the following new Schedule substituted therefor —

### "FIRST SCHEDULE

section 18(1)

## Administrative expenses and fees for safe-keeping -

From 25 cents to 50 cents per month for every \$100 of the value of the article pawned.".
